## Amendment #2

To

### Invitation For Bids (IFB) Sexual Offender Treatment Services Solicitation No. DPSCS Q0015020

Ladies and Gentlemen:

This Addendum is being issued to amend and clarify certain information contained in the above named IFB. All information contained herein is binding on all Bidders who respond to this IFB. The following changes and additions are listed below; new language has been double underlined and marked in **red** bold (ex. **new language**) and language deleted has been marked with a double strikeout (ex. ~~language deleted~~).

1. Revise IFB **Section 3.13.2** to read as follows:

3.13.2 Contractor(s) shall maintain ~~Errors and Omissions/Professional Liability insurance~~ **Malpractice Insurance** with minimum limits of \$1,000,000 per occurrence **and \$3,000,000 aggregate.**

2. Revise IFB **Section 3.3.1** as follows:

3.3.1 The Contractor(s) shall have one or more offices **within the State of Maryland** where assessments and treatment services can be provided. The office(s) shall be located in areas accessible by public transportation or shall not result in more than 30 miles of travel from the assigned offender reporting location. The Department will not be responsible for any office(s) costs. 3. Revise IFB **Section 3.3** to add **Section 3.3.4** as follows:

**3.3.4 Sexual Offender Treatment Services provided under the terms of this Contract must be performed within the State of Maryland.**
