Competitive Grants Summary

To support the General Assembly's goal to promote the pursuit of funding opportunities that align with State priorities, the Department of Budget and Management has prepared a comprehensive report that summarizes all competitive grant opportunities pursued by the State from the Infrastructure Investment and Jobs Act (IIJA) and Inflation Reduction Act (IRA). The State will provide quarterly updates.

The report contains a list of agencies that pursued competitive funds from IIJA and IRA along with the status of the application, and any State match that is required. Information is presented in two ways: by the State Agency, to provide insight into how each agency has pursued funding and by Funding Source. Four additional agencies reported funding opportunities in the current reporting period, for a total of nine agencies.

For certain programs, such as FEMA's Building Resilient Infrastructure and Communities (BRIC), the State acts as the sole applicant of any funds awarded across all State or local jurisdictions. For this report, we displayed only grants the State will administer directly and excluded those that will be implemented by local jurisdictions (i.e., subapplicants). Additionally, in a few instances, funds requested through IIJA and IRA programs may be part of larger projects with multiple funding sources. In these cases, we displayed only amounts that pertain to funding requested through IIJA and IRA.
