\$5.0 Million (T00G00.05)

Purpose: Recovery Now Funding

The Council shall provide emergency art grants to artists, art districts, and art organizations. Organizations that have not received prior funding from the Council or that do not qualify for funding under other Council programs will receive priority.

June 2 - Program Highlights and Plans to Allocate Remaining Balance:

- All funds have been allocated.
- All returned Grant Agreement Forms (approximately 790) have been countersigned.
- Commerce is following up with recipients who have not returned grant agreement forms.
 - Per MSAC policy, reminders are sent via email every other day to grant recipients who have not returned grant agreement forms by the stated deadline (3 days after notification). After 3 emails, MSAC staff contact recipients via phone. If no response after 48 hours following 3 emails and phone contact, the grant may be declined.
