

**Non-Profit Assistance Grants,
Department of Housing and Community Development
\$20.0 Million (S00A24.01)**

Purpose: Recovery Now Funding

The DHCD shall distribute funds to local governments to provide grants to non-profits that can demonstrate need, with priority given to organizations that have not received assistance through the Neighborhood Revitalization Program.

April 7 - Program Highlights and Plans to Allocate Remaining Balance:

- DHCD shall distribute the funds based on the population of the counties and Baltimore City. The funds will be awarded to the county economic development offices or other county agency as identified by the local jurisdiction and the City of Baltimore will receive the funds directly. Each awardee shall utilize its own local grant program to distribute funds and shall prioritize awards to nonprofits that have not already received relief funds from DHCD’s Nonprofit Recovery Initiative (NORI). DHCD will distribute the funds to the local governments by April 30 and the local governments will award grants to nonprofits no later than September 1.
