

**Temporary Disability Assistance Program, Department of Human Services**  
 \$22.0 Million (N00G00.08)

**Purpose: Recovery Now Funding**

For the rest of FY21, assistance under the program will be increased by \$100 each month. Recipients shall not be removed from the program before July 1, 2021, except due to a final determination of a Supplemental Security Income claim. In addition, a recipient who was denied payments on or after July 1, 2020, shall be retroactively reenrolled, also until July 1, 2021, subject to the same restriction.

**June 2 - Program Highlights and Plans to Allocate Remaining Balance:**

- From February 2021 through May 11, 2021, 12,702 recipients received a monthly benefit increase of \$100.
- As of May 25, 2021, 3,808 of TDAP cases eligible for reopening have been reopened retroactively to their date of closure, no further back than July 1, 2020.
- Total spending for the program, through May 25, 2021, is \$8,102,889.

**June 2 - Programmatic and/or Implementation Issues:**

- Outstanding TDAP cases that have not yet been reopened are due to earned income discovered on the case. CARES will not allow earned income to be disregarded for TDAP while remaining countable for other federal programs.
