NEWS FOR MANAGING YOUR PRESCRIPTION - DRUG BENEFIT

Plan well. Invest well. Live well.

The State of Maryland has chosen Express Scripts to provide the prescription-drug benefit for all State of Maryland members, effective May 16. The Express Scripts prescription-drug program offers services through a national retail pharmacy network of 56,000 participating pharmacies, including major chains and independent pharmacies, a specialty pharmacy, and convenient home delivery from the Express Scripts PharmacySM. Read this newsletter to learn more about your 2012 prescription-drug benefit and the choices available to you that could save you money while helping to keep you and your family healthy.

Your Prescription-Drug benefit:

Retail Pharmacy - up to 90-day supply

Tier 1: Generic medication

Tier 2: Preferred brand-name medication

Tier 3: Nonpreferred brand-name medication

Home Delivery – up to 90-day supply

Tier 1: Generic medication

Tier 2: Preferred brand-name medication

Tier 3: Nonpreferred brand-name medication

The three-tier prescription-drug benefit works like this:

- Tier one covers *generic* medications only.
- Tier two covers *preferred brand-name* medications drugs that are on your formulary.
- Tier three covers *nonpreferred brand-name* medications drugs that aren't on your formulary.

Glossary of Terms in Your Prescription-Drug Benefit

Generic drugs — Drugs for which the patent has expired, allowing other manufacturers to produce and distribute the product under the chemical name.

Formulary — A list that is created, reviewed and updated by an independent team of doctors and pharmacists. The formulary contains a wide range of generic and brand-name drugs approved by the U.S. Food and Drug Administration (FDA). Preferred drugs are chosen because they're safe and effective, and they save both you and the State of Maryland

Prior Authorization — Certain drugs require prior authorization by Express Scripts in order to meet the conditions of coverage under your plan. If your prescription requires prior authorization, your physician must submit a request to Express Scripts prior to prescribing the drug.

Ordering a New Prescription for the First Time in 2012?

It's **easy to get started** ... just follow these steps:

- Make sure you have at least a 30-day supply of your prescription(s) on hand when you send in your new order, so you don't run out. Express Scripts will start accepting order forms starting May 16 for home delivery of your prescriptions from the Express Scripts Pharmacy.
- 2. Set up your home delivery account with Express Scripts one of three ways:
- Activate your account online after May 16, at Express-Scripts.com*.
- Complete a home delivery order form (available at Express-Scripts.com* or by calling 877.213.3867).
- Let Express Scripts assist in setting up your home delivery; call 877.213.3867.

You can expect delivery of your order within two weeks from the time we receive your prescription.

Need a Refill?

Refill your prescription when you have a 30-day supply of your medication left so you don't run out.

- Sign in to Express-Scripts.com*.
- Call 877.213.3867.

Place your order 24 hours a day, 7 days a week.

Need Your Prescription Now?

- If you need to start taking your medication immediately, make sure you get two prescriptions from your doctor: one for a 30-day supply and one for a 90-day supply.
- 1. Take the 30-day prescription to your local retail pharmacy and get it filled right away.
- 2. Send the 90-day prescription to the Express Scripts Pharmacy.

Currently Using Another Mail Service for Your Prescriptions?

If you are currently enrolled in another mail service program, Express Scripts will automatically transfer your open refills to the Express Scripts Pharmacy. When it comes time to place a refill, simply sign in to Express-Scripts.com* or call 877.213.3867.

Drug Quantity Management

Are you taking multiple pills and purchasing more fills than necessary of a certain medication in order to reach the daily prescription dosage recommended by your doctor? If so, you are probably overpaying for your prescription drugs. That's why the Drug Quantity Management (DQM) program is in place to help you with your unique dosage situation.

Using guidelines recommended by the US Food & Drug Administration (FDA), this program can also save you money since it ensures the most cost-effective product strength is dispensed to you. For example, DQM will guide you to take one 40mg strength tablet instead of two 20mg tablets.

What to do if a higher dosage is unavailable

If you're taking more than one pill to reach your recommend dose, you may be told that you're asking for a refill too soon. In this case, simply ask your pharmacist when your next refill will be available. But, if your prescription is written for a larger amount than the plan covers:

- Your pharmacist can ask your doctor to change your prescription to a higher strength, when one is available. This way, you meet your plan's quantity limit and get the daily dose you need with fewer copayments.
- Or, you can ask your pharmacist to give you the amount your plan covers. You'll pay the appropriate copayment each time.
- Or, if your doctor doesn't agree with the limit, they can call Express Scripts at 877.213.3867 to request a prior authorization, which may allow you to receive a higher quantity.

If your prescription profile indicates you have a medication that is in the DQM program, you can call Express Scripts at 877.213.3867. Please have a list of your medications available to review with a patient care advocate.


Set more Seription-Drug Benefit

Beginning May 16, State of Maryland members will have access to Express-Scripts.com* for 24-hour online access to information regarding your prescription-drug benefit. Visit the website to:
