<sup>6</sup> Reorganized as a separate agency (formerly part of Maryland Insurance Administration) by Chapter 259 of 2008. Under the Affordable Care Act (ACA), the covered population can buy private health insurance due to elimination of preexisting condition limitations. Therefore, HB 489 of 2016 repealed MHIP.

<sup>7</sup> In July 2001, the Office of Smart Growth was created (Chapter 566, Acts of 2001). In June 2003 it was relocated within the Department of Planning.

<sup>8</sup> Authorized in October 2001, the Office of the Deaf and Hard of Hearing began operation in July 2002 (Chapter 537, Acts of 2001).

<sup>9</sup> Chapter 14 of 2018 reorganized the Commission, making it an independent unit within the Maryland State Department of Education.

<sup>10</sup> Chapter 337 of 2017 created the Maryland State Library Agency as an independent entity of state government, separating it from the Maryland State Department of Education.
