Response to DLS Analyst's Review and Recommendations

Joint Hearing with the House Education and Economic Development Subcommittee – and

Senate Education, Business, and Administration Subcommittee – January 29, 2021



Maryland Center for School Safety (MCSS) appreciates the opportunity to update the Committees on the activities of MCSS and respond to the issues raised and recommendations contained in the operating budget analysis prepared by the Department of Legislative Services (DLS).

Fiscal 2020 Safe Schools Fund Closeout

1. MCSS should provide the committees with the disbursement of all Safe Schools Fund monies by jurisdiction in fiscal 2020 as well as identify any unencumbered funds. MCSS should also explain why the additional \$8.5 million in general funds was needed and what steps it has taken to ensure that grants awarded from the Safe Schools Fund align with the authorized appropriation.

A breakdown of the disbursement of the Safe Schools Fund can be found in Appendix A. There are no unencumbered FY 2020 funds.

The fiscal year 2020 budget for the Maryland Center for School Safety (MCSS) included a unique feature whereby the Center's special fund grant programs were financed with general funds. As such, the grant programs are accounted for twice – once under general funds and once under special funds – in the display of the Center's budget. MCSS inadvertently made both the general and special funds available for the Center's school safety and school resource officer grant programs. MCSS worked with MSDE and the Department of Budget and Management (DBM) to resolve this issue. The resolution was a multi-pronged approach. The MCSS stopped issuing grant awards, sought the assistance of the Interagency Commission on School Construction on the availability of IAC School Safety program funds, and requested a deficiency appropriation from DBM. The FY 2020 deficiency appropriation, coupled with the reduced number of grant awards resolved this issue.

Moving forward, the MCSS is well aware of the unique manner in which these funds are budgeted and the authorized appropriation for these grant programs.

Key Observations

SRO Coverage Grant

The General Assembly may wish to consider modifying Sections 7-1508 and 7-1512(G) of the Education Article to remove the restrictions on the \$10.0 million SRO Coverage Grant. This would maintain the same level of funding for every jurisdiction in the State but would provide them with a wider breadth of permissible uses of the funding under Section 7-1512(F) should they decide to forgo employing SROs, as many schools already do. This action would require separate legislation.

MCSS concurs. MCSS always welcomes flexibility in its ability to distribute grant funds.

Operating Budget Recommended Actions

1. Concur with Governor's allowance.

MCSS concurs.
