## **GO Bond Recommended Actions**

- 1. Approve the \$1,784,000 in general obligation bond authorization for the Leonard Calvert House and Site Improvement projects.
- 2. Adopt the following narrative:

Project Encumbrances and Expenditures: The Department of Legislative Services (DLS) and the Department of Budget and Management use the same standard reporting requirements to request updates on annual project encumbrances and expenditures from agencies for both State-owned and grant- and loan-funded projects. DLS is having difficulty in obtaining accurate and up-to-date information in this form for the Site Improvement project happening at the Historic St. Mary's City Commission (HSMCC). This committee narrative requires HSMCC to submit a report by December 1, 2023, that outlines year-to-date encumbrances and expenditures for the annually funded Site Improvement project that began in fiscal 2022. The report should list each site upgrade funded under the Site Improvement project, the funds associated, and a status update.

The Office of Capital Budgeting (DBM) has completed its review of the Part I facility program for Site Improvements at Historic St. Mary's City (HSMC) and the FY 2023 – FY 2026 "Part II" project list. DBM hereby approves the projects list below. DBM's approval is based on capital eligibility. If the Historic St. Mary's City Commission (HSMCC) wishes to fund additional projects not included in this list, DBM must review and approve those projects. DBM understands that HSMCC will seek independent procurement authority from the Department of General Services (DGS) for smaller projects such as the Replacement of Ghost Frames and others deemed appropriate. DGS must agree to transfer this authority and will be responsible for managing all other projects.

HSMCC has 13 projects in the FY 2023 Capital Site Improvement listed below. Projects 1-9, DGS has taken over project management and procurement. DGS has assigned project managers and is currently developing scopes of work for each project in conjunction with HSMCC. Projects 10-13 under \$50,000, HSMCC will develop and put out for bid once we have independent procurement authority.
