

# **Student Services Building**

A new Student Services Building (SSB) will centralize critical student support resources on the UMBC campus. The project promises to create a hub of studentcentered activity at the heart of campus nearby student housing, the AOK Library, and The Commons.

Conceived as a place well-suited to collaborative opportunities, the SSB will expand the ways students engage with each other outside of the classroom.

In addition to addressing space needs, the project will conspicuously support the key strategic goal of enhancing each UMBC student's complete experience: from the very first time they tour campus to their future involvement as Retriever alumni.

# Janet and Walter Sondheim Hall Renovation

Janet and Walter Sondheim Hall is home to teaching and research that promote the health and well-being of people and communities throughout Maryland. Much of this is through engaged scholarship activities that require accessible, welcoming, and collaborative spaces that are lacking in the building.

The Sondheim Hall project is emblematic of UMBC's commitment to expanding opportunities in graduate and undergraduate research: psychologists, human geographers, ecologists, data scientists, and policy analysts work in labs that are only steps away from classrooms.

In FY2022, research conducted in Sondheim Hall represented more than 10% of UMBC R&D expenditures reported to the National Science Foundation. The building renewal project will make urgently needed modernizations to this 50-year-old facility to provide a suitable home for a 21st century research enterprise and support UMBC's R1 status.

- Develops spaces optimized to support student engagement with research and welcoming to community partners.
- Avoidance of \$60+ M in capital expenditures by not constructing a comparable new building.
- Extends the useful life of Sondheim another 50 years.

# Sherman Hall Renovation

Renewal of Sherman Hall is underway with Phase I construction finishing in summer 2025 and Phase II in fall 2026.

Sherman Hall is the heart of UMBC's investments in STEM education with a special emphasis (through both the Sherman and Meyerhoff Scholars programs) on supporting high-needs areas that have a legacy of being underserved.

We thank the state for its support of the Sherman Hall renewal.



### Return On Investment

- Avoidance of future costly repairs.
- Avoidance of \$65 M in capital expenditures by not constructing a comparable new building.
- Extends the useful life of Sherman Hall another 50 years.
