



Student Services Building

To enhance the hub of student-centered activity at the heart of campus, a new Student Services Building (SSB) will centralize critical student support resources directly adjacent to student housing, the Albin O. Kuhn Library, the Center for Well-Being, and The Commons.

Providing students all-inclusive, ready access to vital services such as proactive advising, financial aid, transfer pathways, and career-readiness, in the SSB will help every student thrive.

Retrievers—no matter their pathway to higher education—will be uplifted along their journey to find their place in Maryland's workforce, make an impact, and give back.

The SSB addresses urgent space needs and centers the student experience—and the building will be much more than a building: It will be a cornerstone of UMBC's growing legacy of inclusive excellence.

Investing in Maryland's Future

- **Increase** students' satisfaction with service delivery and persistence along their path to graduation.
- Increase student retention and enhance recruitment.
- Equip students to navigate transfer pathways, first-generation and working student challenges, and neurodiverse learning opportunities.

- Innovate ways for student veterans and other adult learners to gain access to new career opportunities.

Janet and Walter Sondheim Hall Renovation

The building renewal of Janet and Walter Sondheim Hall will make urgently needed modernizations to this 50-year-old facility, and provide a suitable home for a 21st century research enterprise supporting UMBC's R1 status.

Sondheim Hall is home to teaching and research that promotes the health and well-being of people and communities throughout Maryland. Real work with real impact is being conducted in labs just steps away from classrooms. Psychologists, human geographers, ecologists, data scientists, policy analysts, and students of all majors are pursuing academic scholarship that requires accessible, welcoming, and collaborative spaces that are currently lacking in the building.

The Sondheim Hall project is emblematic of UMBC's commitment to expanding opportunities in graduate and undergraduate research. In FY2023, research conducted in Sondheim Hall represented more than 10% of UMBC R&D expenditures reported to the National Science Foundation.

Sherman Hall Renovation

Sherman Hall represents the heart of UMBC's investments in STEM education with a special emphasis (through both the Sherman and Meyerhoff Scholars Programs) on supporting high-needs areas that have a legacy of being underserved.

The ongoing renewal of Sherman Hall is underway with Phase I opening in fall 2025 and Phase II in spring 2027.
