Introduction

The Maryland Department of Emergency Management (MDEM) appreciates this opportunity to update the Committee on the activities of the Department and to respond to the recommendations and requested updates contained in the Operating Budget analysis prepared by the Department of Legislative Services (DLS).

Department Response to DLS Analysis

Operating Budget Summary Personnel Data

The Department of Legislative Services (DLS) recommends deleting funding for the 2 new administrative positions. MDEM should instead reclassify 2 of the existing long-term vacant positions (p. 8).

Given the high level of uncertainty surrounding federal funding and the importance of the State Disaster Recovery Fund program development and administration, the Department disagrees with the DLS recommendation to remove funding for the positions identified in the Governor's Allowance.

MDEM currently has four PINs which have been vacant for at least one year, all of which are in process of reclassification or hiring. Table 1 below demonstrates the status of those PINS.

Key Observations

- 1. Resilient Maryland Revolving Loan Fund
 - a. MDEM should comment on the status of the five-year plan that it has been developing for the RMRLF and provide updates on the approved RMRLF awards for the project applications listed in Exhibit 5 (p. 11).

MDEM is in the process of adjusting the five year plan based on staffing changes and budget reductions to sustain the program. The estimated overall cost is \$350,000 per year to administer the program, \$1.75 million over five years, which includes program staffing, software, and costs associated with travel, training, and equipment to support technical assistance and outreach to local jurisdictions.

b. DLS recommends amending the BRFA provision to increase the authorized transfer by \$3.0 million, for a total of \$12 million transferred from the RMRLF to the General Fund in fiscal 2025. Additionally, DLS recommends adopting committee narrative requesting that MDEM submit a report on the RMRLF, including efforts taken by MDEM to assist local governments with developing project proposals and applications for future federal awards (p. 11).

Further reduction of the Resilient Maryland Revolving Loan Fund beyond the \$9 million identified by the Governor's Allowance could jeopardize the State's ability to support local jurisdictions to meet matching requirements for disaster risk reduction funding including the Congressionally Directed Spending Pre-Disaster Mitigation program and the Building Resilient Infrastructure and Communities (BRIC) program. MDEM has successfully leveraged RLF funds to bring in \$20 million in STORM funds and more than \$38 million in BRIC and PDM funding in just the last two fiscal years. While the program was initially delayed due to federal NOFO delays for the companion STORM Act, the Department continues to receive notice of interest from local governments seeking to reduce risk of disasters to their residents. MDEM submitted a budget amendment in SFY25 in order to draw down funds for RLF operations. As federal funding increases in uncertainty, MDEM encourages the Committees to only reduce the Resilient Maryland Revolving Loan Fund by the Governor's Allowance amount of \$9 million in order to ensure vital community

projects aimed at saving lives and reducing disaster impacts to properties remain viable in the future.

MDEM continues to perform outreach to local emergency managers and other key disaster risk stakeholders. The Department is currently working closely with the Anne Arundel County Resilience Authority, who is interested in a future project to benefit areas such as Annapolis and/or Glen Burnie.

2. State and Local Cybersecurity Efforts

a. MDEM should comment on when federal fiscal 2023 and 2024 funding will be allocated and provide fund allocations by local project and by purpose (p. 14).

The table below outlines the funds grants to Maryland under the State and Local Cybersecurity Grant Program (SLCGP), administered by MDEM.

As described in the November 1 Joint Chairmen's Report response, the Department Co-Chairs and staffs the SLCGP Committee, an interdisciplinary body including representation from State and local governments, academic institutions and school systems which collectively determines the use of federally-awarded funds. The SLCGP Committee has approved the projects outlined in Appendix A of this document for federal fiscal year 2023 (FFY23) funding. All projects are awaiting FEMA approval.

Once the spend plan for FFY24 is determined and finalized by the SLCGP, MDEM will submit the plan for FEMA review and approval. MDEM would note for the Committees that SLCGP is an IIJA-funded grant, and MDEM is awaiting guidance from FEMA on funding opportunities for future years given recent federal actions. MDEM will include any updates in future JCR reports as recommended in 2(b) of this analysis.
