REQUESTING AGENCY REMARKS: A notice of the availability of the Invitation for Bids (IFB) was advertised on *eMarylandMarketplace.com*, and the Department of Budget and Management (DBM) and DPSCS websites. Copies of the solicitation notice were emailed directly to 34 prospective vendors, five of which are Maryland firms, and none are MBEs. A copy was also sent to the Governor's Office of Minority Affairs.

Seven bids were received in response to the IFB, all of which were determined to be responsive. Award is recommended to the lowest responsible bidder, Phamatech, Inc.

DPSCS is one of the largest departments in Maryland State government. The major divisions directly related to the detention, custody and supervision of persons who are detained, incarcerated or supervised in the community include the Division of Pretrial Detention and

Services, the Division of Correction, Patuxent Institution and the Division of Parole and Probation. On a daily basis, these divisions oversee the custody and community supervision of approximately 100,000 individuals in 23 correctional facilities and 45 parole and probation supervision offices throughout the State. DPSCS' mission is to help make communities safe through effective oversight and supervision. Detecting, deterring and treating substance abusers are essential components in this process.

The drug testing services for this contract will begin as of 10/1/2011; however, time is needed to transition between the incumbent and the new Contractor. Therefore, the two weeks of September will be used as a transition period.

No MBE participation goal was established for this solicitation because there is no guaranteed number of drug tests or expert testimony appearances to be performed and the chain of custody for drug testing must be maintained for the accuracy of test results/analysis. Accordingly, subcontracting opportunities could not be easily established and are very limited.
