SECOND MODIFICATION

TO

DENTAL HEALTH MAINTENANCE ORGANIZATION PLAN ADMINISTRATION AND INSURANCE SERVICES CONTRACT

THIS SECOND MODIFICATION AGREEMENT is made effective this	28th
day of, 2016, by and between Delta Dental of Pennsylvania, Inc. ("Contrad	ctor") and
the State of Maryland, acting through the Department of Budget and Management (("DBM"),
Division of Procurement Policy and Administration and Employee Benefits Division	("EBD")
(collectively, the "Department").	

WHEREAS, on August 13, 2014, the Department entered into a contract with the Contractor to provide Fully-Insured Dental Health Maintenance Organization (DHMO-FI) Plan Administration and Insurance Services (the "Services") pursuant to a Request for Proposals for Dental Plan Administration and Insurance Services, Project No. F10B3400005 issued on August 22, 2013, and all the amendments thereto issued in writing by the State (the "RFP"); and

WHEREAS, the Contract entered into on August 13, 2014, included a Minority Business Enterprise (MBE) subcontractor that the Contractor has found to have performed unsatisfactorily; and

WHEREAS, the Contractor desires to replace said MBE subcontractor with another MBE subcontractor;

NOW, THEREFORE, the Department and Contractor desire to modify the Contract to reflect the selection of a new MBE in order to allow the Contractor to successfully continue to perform the required Services.

IN CONSIDERATION of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the parties agree to modify the Contract as follows:

- 1. MBE Participation Plan. In fulfilling its obligation to meet the MBE Contract goal of .501%, the original MDOT Certified MBE Utilization and Fair Solicitation Affidavit (MBE Form D-1) and Subcontractor Project Participation Certification (MBE Form D-3) for the DHMO-FI Dental Plan Administrative and Insurance Services submitted by the Contractor dated July 3, 2013 and July 15, 2014, respectively, are both replaced in their entirety with the revised MBE Forms D-1 and D-3 dated June 16, 2016 and June 17, 2016, respectively, attached hereto and incorporated by reference herein.
- 2. Scope of Modification. This Second Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of this Modification, all of the terms of the Contract shall remain in full force and effect and are hereby ratified and confirmed.
