PRE-PROPOSAL CONFERENCE SUMMARY October 24, 2007, 10:00 AM Project No. F10B8200006

Project Title: Group Term Life and Personal Accident and Dismemberment (PA&D) Insurance

Ladies/Gentlemen:

The State of Maryland conducted a Pre-Proposal Conference in Room 164A/B, 45 Calvert Street, Annapolis, MD 21401, on October 24, 2007. An attendance list with the names of those attendees signing in is Attachment 1.

This Summary is being issued to document the Pre-Proposal Conference. The Procurement Officer, Joe Gatto, convened the conference, recognized the State and Department (DBM) people present, and reiterated that all vendors should sign in.

Mr. Norm Grinnell then reviewed the RFP:

- Section 1—General Information (reviewed topics related to method, type, duration, terms and conditions of the solicitation);
- Section 2—Minimum Qualifications (reviewed importance of the min quals in that if not met, an Offeror's proposal would not make it to the evaluation stage);
- Section 4—Proposal Submission Format (reviewed all the elements required to meet administrative and content requirements for technical and financial proposals);
- Section 5—Evaluation Criteria and Selection Procedure (explained evaluation process and how State selects the best proposal);
- Attachment A—Contract (pointed out that RFP, contract and contractor proposals represent State expectations and requirements and that all referenced exhibits are included in the contract);
- Attachment B—Bid/Proposal Affidavit (emphasized all blanks are to be filled in and that
 "domestic corporation" means a corporation registered in Maryland and a foreign corporation
 means a corporation not registered in Maryland; also, the affidavit must be submitted with the
 tech proposal);
- Attachment C—Contract Affidavit (explained contract affidavit is reaffirmation of bid/proposal affidavit and not required to be submitted with the technical proposal);
- Attachment D—Minority Business Enterprise Participation (reviewed MBE subcontracting goal and explained the fact some MBE forms errors are not curable and that forms must be submitted to remain as an Offeror) (Presented by Mr. Tom McLamore);
- Attachment F—Price Proposal Instructions and Form (discussed elements of price sheets and that conditions are not acceptable);

- Attachment G—Procurement Officer's Checklist (advised Offerors to use checklist to be certain all required elements of the proposal are present in the submission);
- Attachment I—Non-Disclosure Agreement (NDA) (explained access to protected information on eligible and insured members can be granted only after execution of the NDA);
- Attachment J—Living Wage Requirements for Service Contracts (explained the Living Wage law provisions and the requirements for State Contractors under the law);
- Attachment K—Living Wage Affidavit of Agreement (explained the affidavit means acceptance of the terms of the Living Wage law and a promise to comply with reporting requirements); and
- Attachment L—Performance Guarantees and Liquidated Damages (explained liquidated damages are not penalties but a representation of the cost to the State of a failure to perform; liquidated damages used as a contract management tool in monitoring and assuring performance standards and deliverables under the contract are met).

Ms. Anne Timmons reviewed the work requirements of the RFP:

• Section 3—Scope of Work (reviewed the background, eligible population served and insurance requirements for both group life and PA&D)

Mr. Grinnell reviewed ten of the questions asked so far with the promise to provide written responses to the questions asked thus far. The floor was then opened to questions with the caveat that formal written answers to questions would only be given if the question were submitted in writing, preferably by e-mail. The questions covered issues such as MBE performance on the current contract, descriptive information for contractor produced brochure, PA&D exclusions, how soon census information would be transmitted after receipt of the non-disclosure agreement, when a MBE firm has to be identified for submission, dedicated phone lines for direct help and the number of covered lives for PA&D.

The attendees were reminded responses given verbally and other general discussions were non-binding and provided to help give a better understanding of the State's requirements. Mr. Grinnell further stated that any question asked and answered at the conference should be asked formally by e-mail if the questioner wanted a coordinated, official response.
