

**FOURTH MODIFICATION TO UNITED HEALTHCARE SERVICES, INC. HEALTH PLAN
ADMINISTRATION AND SERVICES CONTRACT- FUNCTIONAL AREA 2- EXCLUSIVE
PROVIDER ORGANIZATION (EPO)

THIS FOURTH MODIFICATION AGREEMENT is made effective this 25th day of ~~April~~ June 2018, by and between United HealthCare Services, Inc., (the "Contractor") and the State of Maryland, acting through the Department of Budget and Management (the "Department").

WHEREAS, on August 13, 2014, the Department entered into a contract with the Contractor to provide Health Plan Administration and Services – Functional Area 2 EPO pursuant to Request for Proposals for Health Plan Administrations and Services (PPO, EPO, IHM), Project No. F10B3400022 issued November 26, 2103, and all amendments thereto issued in writing by the State (the "Contract"),

WHEREAS the Contract was modified on December 30, 2014 ("First Modification"), August 17, 2016 ("Second Modification"), and August 8, 2017 ("Third Modification"); and

WHEREAS the parties desire to modify a certain provision of the Contract;

IN CONSIDERATION of the Recitals which are hereby made a substantive part hereof, and the promises and the covenants herein contained, the parties agree to modify the Contract as follows:

- RFP Technical Proposal Attachment S-12: Performance Guarantees** to change the Contractor's time to provide response files to the Department's Audit Unit from within 14 Business Days to within 25 Business Days as follows:
