THIS FIRST MODIFICATION ("FIRST MODIFICATION") is made as of this 11th day of January, 2023 by and between **United Concordia Companies, Inc.** ("United Concordia Dental" or "the Contractor") and the STATE OF MARYLAND, acting through the Department of Budget and Management, Office of Personnel Service and Benefits ("DBM" or the "Department").

WHEREAS, on **September 4, 2019**, the Department entered into a contract with the Contractor for **State of Maryland Dental Plan Administration and Insurance Services, Project No. F10B9400020**, (the "Contract") pursuant to the **Request for Proposals for State of Maryland Dental Plan Administration and Insurance Services, Project No. F10B3400005** dated **December 21, 2018**, and all amendments thereto issued in writing by the State (the "RFP"); and
