Ladies and Gentlemen:

This Amendment #3 is being issued to amend language and clarify information contained in the above-named IFB. All information contained herein is binding on all Bidders who respond to this IFB. The changes are listed below; new language has been double underlined and marked in red bold (ex. <u>new language</u>) and language deleted has been marked with a double strikeout (ex. <u>strike out</u>).

- 1. Revise Section 2.3.1 (**Scope of Work Requirements, General**), as follows:
 - 2.3.1.7 The Contractor agrees to accept files as formatted by the State. The Contractor must be able to transfer electronic files to and from DBM and/or EBD using the State's secure file transfer protocol. Files will have no bleed.

4. Revise Section 2.3.10 (**Open Enrollment Envelopes**), as follows:

2.3.10.1 The Contractor will print the approximately 135,000 open enrollment envelopes: 80,000 with indicia and 55,000 without indicia. Envelopes are 9" × 12", booklet style on the 12" edge. 2 color on 70# recycled opaque text and white, with poly covered windows. The ink is black and one color.

5. Revise Section 2.3.12 (**COBRA Mailings**), as follows:

2.3.12.2 The COBRA printings are as follows. All are black ink on 50# white paper with pages trimmed to $8\frac{1}{2}$ " × 11" and stapled.
