THIRD MODIFICATION TO SPECIMEN COLLECTIONS CONTRACT NO. 050B7400009

THIS THIRD MODIFICATION AGREEMENT (the "Third Modification") is made as of this <u>17th day of October, 2022</u> by and between **Progressive Phlebotomy Services, LLC** (the "Contractor") and the STATE OF MARYLAND, acting through the **Department of Budget and Management** ("the Department").

WHEREAS, on January 24, 2018, the Department entered into a contract with the Contractor to provide specimen collections (the "Contract") pursuant to the Invitation for Bids for Specimen Collections, Project No. 050B7400009, dated September 21, 2017, and all amendments thereto issued in writing by the State (the "IFB"); and

WHEREAS, the Department and Contractor modified the Contract to amend the list of collection sites on May 2, 2018 ("Modification 1"); and


WHEREAS, the Department and Contractor modified the Contract to amend the list of collection sites on January 25, 2019 ("Modification 2"); and

WHEREAS, the Department and Contractor desire to modify the current list of collection sites so that the Contractor can successfully continue services under the Contract.

NOW, THEREFORE, IN CONSIDERATION of the Recitals which are hereby made a substantive part hereof, and the mutual promises and covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the Department and Contractor hereby mutually agree to the changes below:

- 1. Attachment-S (Collections Occurrence Sites). The parties have modified IFB Attachment S to reflect the new additions of Site 0023 (Baltimore), Site 0031 (Hagerstown), Site 0044 (Easton), Site 0196 (Annapolis), and Site 0197 (Owings Mills); the deletion of Site 0002 (Anne Arundel County Health Department), and Site 0175 (J. DeWeese Carter Youth Facility); and to reflect an address change for Site 0149 (Baltimore) and Site 0170 (from Frederick to Hagerstown), all as indicated on Amended Attachment S, attached hereto and incorporated by reference herein.
- 2. **Scope of Third Modification.** This Third Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of this Third Modification, all of the terms of the Contract shall remain in full force and effect and shall apply to this Third Modification.
