This program funds projects that support public-private partnerships in continuing conservation goals that involve long-term protection, restoration or enhancement of wetlands to maintain or improve the benefits to wetlands-associated migratory birds and waterfowl.

This competitive program seeks to fund projects that further the goals of the North American Wetlands Conservation Act through restorative projects that preserve and improve wetland wildlife habitats.
