- **Creditor**-A Creditor is a State of Maryland affiliated enterprise or organization that refers delinquent accounts to the CCU. Creditors are state agencies, independent boards, commissions, colleges, universities, divisions, subdivisions, or sections (Previously referred to as Client).
- **Creditor Short Name**-Will replace Client #. See page 24-33 for a full list of all Creditor Short Names.
- **Tags**-Tags identify or classify debtors and/or accounts and will replace CCU status codes. Tags can be account based or debtor based which help move accounts through the collection processes. For a list of Legacy Status Codes to Debt Manager Tags Mapping, see pages 21-23.
