

**MODIFICATION 1 OF THE
DRUG TESTING CONTRACT
BETWEEN THE STATE OF MARYLAND
DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES
AND
PHAMATECH, INCORPORATED
Modification # Q0012004-1**

THIS Modification No. Q0012004-1 to Contract Q0012004 dated September 12, 2011, by and between the State of Maryland, acting through the Department of Public Safety and Correctional Services (the "Department or DPSCS"), and Phamatech Incorporated ("the Contractor").

WHEREAS, parties desire to add Gas Chromatography Mass Spectrometry (GC/MS) testing to the contract and to modify Attachment G (Certification of Analysis Form) of Exhibit A to the Contract and;

NOW THEREFORE, THIS AGREEMENT WITNESSETH: That for and in consideration of and subject to the mutual covenants and conditions hereinafter set forth, the Department and the Contractor hereby agree as follows:

- I. Effective as of July 8, 2013, the following provisions replace in their entirety, the like-numbered provisions of the Contract:

- 2.1 The Contractor shall provide the drug testing services described in the Contractor's Bid and the IFB to include Gas Chromatography Mass Spectrometry (GC/MS) confirmation testing. These services shall be provided in accordance with this Contract and the following exhibits, which are attached and incorporated herein by reference. If there is any conflict between this Contract and the Exhibits, the terms of the Contract shall govern. If there is any conflict among the Exhibits, the following order of precedence shall determine the prevailing provision:

Exhibit A- The IFB
Exhibit B- The Contractor's bid
Exhibit C- Contract Affidavit

- 4.1 The Contractor shall be paid the not to exceed amount in the Contract at the pricing identified in the Contractor's bid and this Modification 1:
