Specific parts of the RFP have been amended. For each functional area proposed, an unbound original and six (6) bound copies of each proposal (technical and financial) must be received by the Procurement Officer, at the address listed in Section 1.7, no later than 2:00 PM (local time) on June 6 **18**, 2008 in order to be considered. An electronic version on CD of the Technical Proposal (in MS Excel format and MS Word, as appropriate) copied on two (2) CD's must be enclosed with the original Technical Proposal. An electronic version on two (2) CD's of the Financial Proposal in MS Excel format must be enclosed with the original Financial Proposal. Ensure that the CD's are labeled with the RFP title, RFP number, functional area, Offeror name and packaged with the original copy of the appropriate proposal (technical or financial).

Requests for extension of this date or time will not be granted. Offerors mailing proposals should allow sufficient mail delivery time to ensure timely receipt by the Procurement Officer. Except as provided in COMAR 21.05.03.02F, proposals received by the Procurement Officer after the due date June 6 **18**, 2008 at 2:00 PM (local time) will not be considered. Proposals may not be submitted by e-mail or facsimile.
