

**THIRD MODIFICATION TO GROUP TERM LIFE AND PERSONAL ACCIDENT AND  
DISMEMBERMENT (PA&D) INSURANCE SERVICES CONTRACT**

**THIS MODIFICATION AGREEMENT** is made effective this 29<sup>th</sup> day of March, 2010 by and between Metropolitan Life Insurance Company ("Contractor") and the State of Maryland, acting through the Department of Budget and Management.

**WHEREAS**, the Minority Business Enterprise ("MBE") Simmonsink!, originally selected to provide services in connection with the Contract, is no longer capable of performing services due to its termination of business operations, effective August 9, 2009;

**NOW THEREFORE** in consideration of the promises and the covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, and pursuant to COMAR 21.11.03.12, the parties agree to modify the Contract for Group Term Life and Personal Accident and Dismemberment (PA&D) Insurance Services dated February 19, 2008, amended by a First Modification dated April 17, 2008 and a Second Modification dated July 1, 2009, by and between the State and Metropolitan Life Insurance Company ("Contract"), as follows:

**1. MBE Participation Plan.** To fulfill its obligation to meet its MBE participation commitment of 1.8% of the premiums paid, the Contractor shall use **Curry Printing & Copy Center** (Certification No. 96-321) to provide services in connection with the Contract. The original Attachment D-1, dated 11/14/2007, remains in full force and effect. The attached revised Attachments D-2 and D-4, dated February 2, 2010, shall be incorporated into the Contract. Services provided by and compensation paid to Simmonsink! prior to the effective date of this Third Modification shall be considered to determine whether the Contractor meets its obligations in connection with MBE participation under the Contract.

**2. Scope of Modification.** This Third Modification amends the contract specifically as described herein. Except as specifically revised by the terms of Modification #1, Modification #2 and this Modification #3, all of the terms of the Contract shall remain in full force and effect and are hereby ratified and confirmed.
