

**SECOND MODIFICATION TO
STATE OF MARYLAND DENTAL PLAN ADMINISTRATION AND INSURANCE SERVICES
FUNCTIONAL AREA 1 – FULLY INSURED DENTAL HEALTH MAINTENANCE ORGANIZATION
(DHMO-FI)

THIS SECOND MODIFICATION (“SECOND MODIFICATION”) is made as of this 27th day of April, 2023, by and between Delta Dental of Pennsylvania, Inc. (the “Contractor”) and the STATE OF MARYLAND, acting through the Department of Budget and Management, Office of Personnel Service and Benefits (the “Department”).

WHEREAS, on **September 4, 2019**, the Department entered into a contract with the Contractor for **State of Maryland Dental Plan Administration and Insurance Services, Project No. F10B9400020**, (the “Contract”) pursuant to the **Request for Proposals for State of Maryland Dental Plan Administration and Insurance Services, Project No. F10B9400020** dated **December 21, 2018**, and all amendments thereto issued in writing by the State (the “RFP”); and

WHEREAS, the Contractor has requested to replace one Minority Business Enterprise (MBE) subcontractor in its plan in order to meet or exceed the Contract’s MBE participation goal; and

WHEREAS, the Department and Contractor desire to modify the Contract in order to amend the Contractor’s MBE Utilization and Fair Solicitation Affidavit & MBE Participation Schedule and Certified MBE Subcontractor Participation Certification (collectively, the “Original MBE Plan”) in order to reflect the replacement of the MBE subcontractor.

NOW, THEREFORE, IN CONSIDERATION of the Recitals which are hereby made a substantive part hereof, and the mutual promises and covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the Department and Contractor hereby mutually agree to the changes below.

1. MBE Participation Plan.

1.1 The Original MBE Plan is hereby replaced in its entirety with the revised complete MBE Utilization and Fair Solicitation Affidavit & MBE Participation Schedule and Certified MBE Subcontractor Participation Certification (MBE Attachments D-1A and D-3A, respectively) (collectively, the “Revised MBE Plan”), attached hereto and incorporated into the Contract by reference herein.

1.2 The Contractor represents and warrants that it will continue to meet its promised obligation to its current MBE subcontractor(s):

Workforce Resources, Inc.
The Well Workplace, LLC, DBA WellAdvantage

Implementation of the corrective plan herein and the replacement of the one MBE in the Revised MBE Plan identified above in Section 1.1 for the Contract shall not adversely affect the volume, amount, and value of the work provided to the remaining MBEs identified in the Original MBE Plan. The Contractor agrees that each such MBE will continue to be utilized to the maximum extent possible under the Contract, including the new MBE, identified below.

- 1.3 The Contractor represents and warrants that it will meet its promised obligation to its new MBE subcontractor:

Black Classic Press, Inc. aka BCP Digital Printing

- 1.4 The Contractor also represents and warrants that it is unable to continue to meet its promised obligation to the MBE subcontractor being replaced (and identified below) for the following reason:

Patricia Litho, LTD

The referenced firm has lost its MBE status due to a business acquisition resulting in the company exceeding its personal net worth cap with MDOT, subsequently graduating from the MBE program.

- 2. Scope of Second Modification.** This Second Modification amends the Contract specifically as described herein. The Revised MBE Plan shall be in full force and effect as of the date of this Second Modification. Any services provided by and any compensation paid to Black Classic Press, Inc. aka BCP Digital Printing, the new MBE, prior to the effective date of this Second Modification shall be considered and allowable toward the Contractor meeting its obligations in connection with MBE participation under the Contract. Except as specifically revised by the terms of this Second Modification, all of the terms of the Contract shall remain in full force and effect and shall apply to this Second Modification.
