

**FIRST MODIFICATION TO  
STATEWIDE DEBT COLLECTION SERVICES  
CONTRACT NO. F10B9200003**

**THIS FIRST MODIFICATION AGREEMENT** (the "Modification") is made this 29<sup>th</sup> day of JANUARY, 2014, by and between NCO Financial Systems, Inc. ("NCO") and the State of Maryland, acting through the Department of Budget And Management, Division of Procurement Policy and Administration, Central Collection Unit ("CCU").

**NOW THEREFORE, IN CONSIDERATION** of the promises and the covenants herein contained, the parties agree to modify the contract dated April 18, 2009 for Statewide Debt Collection Services (the "Contract"), as follows:

**1. Delete the first sentence of IFB Section 2.5 (Maryland State Office and Licensing) as follows:**

~~The Contractor's primary office must be located within the State of Maryland or within 100 miles of the CCU office located at 300 W. Preston Street in Baltimore, Maryland from which services will be rendered.~~ The CCU reserves the right to approve/deny any changes to the primary office location during the term of the contract. The bidder's response must identify the address of the bidder's principal (corporate) office and identify the address of the primary office, as required in their response to Attachment E, No. 12. The bidder must be licensed in Maryland by the Department of Labor, Licensing & Regulation's Commissioner of Financial Regulation as a collection agency.

**2. Revise Contract Section 1.3 (Definitions) as follows:**

"Contractor" means NCO Financial Systems, Inc. whose principal business address is 507 Prudential Road, Horsham, PA 19044 and whose primary office from which the Contractor shall operate for the remaining duration of the Contract is 5626 Frantz Road, Dublin, Ohio 43017.

**3. Revise Contract Section 3 (Time for Performance) as follows:**

Unless terminated earlier as provided in the Contract, the term of the Contract shall be extended for a period of one year to include the period May 1, 2014 through and ending on April 30, 2015.

**4. Scope of Modification.**

This Modification amends the IFB and the Contract specifically as described herein. Except as specifically revised by the terms of this Modification, all of the terms of the IFB and the Contract shall remain in full force and effect and shall apply to this Modification.


