

**Second Modification to  
Statewide Language Interpretation Services Contract  
PRIMARY CONTRACTOR: SCHREIBER TRANSLATIONS, INC.**

**Service Category III- Written Document Language Translation**

This Modification (the "Modification") is made this <sup>13<sup>th</sup></sup> day of February, 2009, by and between the STATE OF MARYLAND, DEPARTMENT OF BUDGET AND MANAGEMENT (the "Department"), DIVISION OF PROCUREMENT POLICY AND ADMINISTRATION and SCHREIBER TRANSLATIONS, INC. (hereinafter referred to "Contractor").

WHEREAS, on June 25, 2007, the Department entered into a contract to provide Written Document Language Translation Services for Service Category III (the "Services") with Contractor (the "Contract") pursuant to Request For Proposals for Statewide Language Interpretation Services, Project No. 050B7800015, dated October 17, 2006, and all amendments thereto issued in writing by the State (the "RFP").

WHEREAS, the Department and Contractor desire to modify the Contract so that Contractor can successfully continue to perform the Services.

NOW, THEREFORE, in consideration of the Recitals which are hereby made a substantive part hereof, and the mutual promises and covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the Department and Contractor hereby mutually agree to the changes below.

**1. MBE Participation Plan.** In fulfilling its obligation to meet the MBE goal of 15% set in the RFP and incorporated into the Contract, the Minority Business Enterprise (MBE) participation plan for foreign language document translation services for multiple languages submitted by the Contractor in Forms D-2 and D-4 dated 04/17/2007 and 06/08/2007, respectively (collectively, the "Original Plan") is replaced in its entirety with the revised participation plan for foreign language document translation services for multiple languages identified on revised Forms D-2 and D-4, attached hereto and incorporated by reference herein (collectively, the "Revised Plan").

- a. The Original Plan identified participation as follows:
  - i. Academy of Languages 15.0%
  - ii. Total MBE participation 15.0%.
  
- b. The Revised Plan identifies participation as follows:
  - i. Academy of Languages 7.0%
  - ii. Translation Source, LTD 8.0%
  - iii. Total MBE participation 15.0%.
  
- c. The original Form D-1 dated 12/12/2006 remains in full force and effect.

2. **30.3-Notices.** The Contractor contact in Section 30.3-Notices is hereby replaced as follows:

3. **Scope of Modification.** This Second Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of Modification #1 and this Second Modification, all of the terms of the Contract shall remain in full force and effect and are hereby ratified and confirmed.




