

**THIRD MODIFICATION TO  
VISUAL COMMUNICATION SERVICES CONTRACT  
VIDEO REMOTE INTERPRETATION (VRI) SERVICES  
CATEGORY III**

This THIRD MODIFICATION is made as of this 18 day of December, 2018 by and between Purple Communications, Inc. (Contractor) and the State of Maryland, acting through the Department of Budget and Management.

WHEREAS, on November 12, 2013, the Department entered into a contract with Contractor for Statewide Visual Communication Services, Project No. 050B3400001, amended by a First Modification dated May 12, 2014 and a Second Modification dated January 1, 2017, (collectively, (the "Contract") pursuant to the Request for Proposals for Visual Communication Services, Project No. 050B3400001 dated September 28, 2012, and all amendments thereto issued in writing by the State (the "RFP").

WHEREAS, the parties desire to extend the Contract, while the Department conducts a new procurement for services and awards a new contract, to ensure continuity of Video Remote Interpretation services on a statewide basis.

NOW THEREFORE, IN CONSIDERATION of the promises and the covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows;

1. **Defined Terms.** All capitalized terms used in this Third Modification shall have the same meaning as provided in the Contract or the RFP, whichever is applicable.
2. **Duration of Contract.** The Contract term under Contract §3, Time for Performance, is hereby extended one month from January 1, 2019 through December 31, 2019 unless terminated earlier as provided in the Contract.
3. **Consideration and Payment.** Payment to the Contractor for the services under the Contract shall remain the same as stated in Option Year One of the Contractor's Financial Proposal, RFP Attachment F.
4. **Scope of Third Modification.** This Third Modification amends the Contract specifically as described herein. Except as specifically revised by the terms of this Third Modification, all of the terms of the Contract shall remain in full force and effect and shall apply to this Third Modification.
