Ladies/Gentlemen:

This list of Questions and Answers #2 (Nos. 6 through 8) is being issued to answer questions recently received and to answer the last question from Questions and Answers #1 document which was incorrectly listed as question number 4 and should be number 5. The statements and interpretations of contract requirements, which are stated in the following questions of potential offerors, are not binding on the State, unless the State expressly amends the RFP. Nothing in the State's responses to these questions is to be construed as agreement to or acceptance by the State of any statement or interpretation on the part of the vendor asking the question as to what the contract does or does not require.

Question number 5 (formerly marked as the second #4) from Q&A #1:

5. Does the WebFleet RFP comply with Section 508 of the Federal Regulations which amended the Rehabilitation Act to require Federal agencies to make their electronic and information technology accessible to people with disabilities?

**RESPONSE:**

The WebFleet RFP complies with Maryland law for non-visual access. Section 1.30 in the RFP addresses compliance.

6. Where is the contract service being performed (which location eg., offsite or onsite)?

**RESPONSE:**

The contract services are being performed on the servers which are located at 45 Calvert Street in Annapolis. The current contractor provides 95% of their services offsite through the Department of Information Technology's virtual private network (VPN).

7. Since Microsoft has ended the primary support for ASP in year 2005, are there any enhancements/upgrading to ASP.NET applications? If so, which version of ASP.NET?

**RESPONSE:**

The State may evaluate the need to upgrade the current application architecture and database based on technical and/or functional considerations during the period of time that the contractor is providing operations and maintenance of the applications. The State currently has no plans to upgrade the application.

8. How many people/resources are needed to execute this project?

**RESPONSE:**

The actual number of people or resources that are needed to execute this project is something that the contractor will have to determine. The current vendor has assigned 1 programmer who has been overseeing this project for the past 5 years.
