

View Legal Name for an Employee or Retiree

Use this procedure to view Legal Name and Name Change History for an employee (or retiree).

Note that SPMS Agency Benefits Coordinators can only view legal names and name change history for their employees. The Employee Benefits Division can view legal names and name change history for all employees and retirees.

Procedure:

- 1. Enter the employee name or W number in the **Search** field.
- 2. Click the **search** icon.
